

## Our Privacy Policy

### How We Collect and Use Information

We may collect the following types of information about you:

Information you provide us directly:

We may ask for certain information such as your real name, birthdate, address, phone number and e-mail address whenever you are doing business with **Rainbow Optimum Technologies**, or if you correspond with us. We may also retain any messages you send through the Service. We use this information to operate, maintain, and to help us serve you better.

### Information we may receive from third parties:

We may receive information about you from third parties. For example, if you access our websites or Service through a third-party connection or log-in, for example, through Facebook Connect, by “following,” “liking,” adding **Rainbow Optimum Technologies**, linking your account to **Rainbow Optimum Technologies** Service, etc., that third party may pass certain information about your use of its service to Rainbow Optimum Technologies & General Contractors.

This information could include, but is not limited to, the user ID associated with your account (for example, your Facebook UID), an access token necessary to access that service, any information that you have permitted the third party to share with us, and any information you have made public in connection with that service. If you allow us access to your friends list, your friends’ user IDs, and your connection to those friends, may be used and stored to make your experience more social, and to allow you to invite your friends to use our Service as well as provide you with updates if and when your friends visit **Rainbow Optimum Technologies** website or any social media advertise on **Rainbow Optimum Technologies** website or any social media.

You should always review, and if necessary, adjust your privacy settings on third-party websites and services before linking or connecting them to **Rainbow Optimum Technologies** Service. You may also unlink your third-party account from the Service by adjusting your settings on the third-party website, link or services.

Inviting a friend to use **Rainbow Optimum Technologies**

**Rainbow Optimum Technologies** may, in its sole discretion, develop a feature that allows you to invite third parties to the Service. If you choose to use our invitation

service to invite a third party to the Service through our “Invite friends” feature, you may directly choose a friend to invite through your mobile device’s native contact list – but we do not require that you import your contacts list to the Service. You understand that by inviting a friend to **Rainbow Optimum Technologies** through the “Invite friends” feature, you are directly sending a text or email from your personal accounts. In addition, you understand and agree that normal carrier charges apply to communications sent from your phone. Since this invitation is coming directly from your email or phone, we do not have access to or control this communication.

### **Finding your friends using our Service:**

**Rainbow Optimum Technologies** may, in its sole discretion, develop a feature that allows you to locate your friends with **Rainbow Optimum Technologies**’ accounts through a “Find friends” feature. The “Find friends” feature allows you to choose to locate friends either through (i) your contact list, (ii) social media sites (such as twitter or Facebook) or (iii) through a search of names and usernames on **Rainbow Optimum Technologies**. If you choose to find your friends through your contact list, then you agree to provide **Rainbow Optimum Technologies** access to your contact list such that we can perform the search necessary to determine whether or not someone associated with the information you provide is using **Rainbow Optimum Technologies**.

If you choose to find your friends through social media sites, then you understand that the information these sites provide to use to conduct this type of search is governed by their privacy policies and your account settings on those sites. If you choose to find your friends through a search of names or usernames, then simply type a name to search and see if that name or username appears on our Service. Note that we do not retain any information contained in your contacts list, or information from social media sites about your contacts, and we do not use such information for any purpose other than to help you find your friends on **Rainbow Optimum Technologies** website or any other social medial site.

### **Analytics information:**

We may directly collect analytics data, or use third-party analytics tools and services, to help us measure traffic and usage trends for the Service. These tools collect information sent by your browser or mobile device, including the pages you visit and other information that assists us in improving the Service. We collect and use this analytics information in aggregate form such that it cannot reasonably be manipulated to identify any particular individual user.

### **Device identifiers:**

When you access the Service by or through a mobile device (including but not limited to smart-phones or tablets), we may access, collect, monitor and/or remotely store one or more “device identifiers,” such as a universally unique identifier (“UUID”). Device identifiers are small data files or similar data structures stored on or associated with your mobile device, which uniquely identify your mobile device. A device identifier may be data stored in connection with the device hardware, data stored in connection with the device’s operating system or other software, or data sent to the device by **Rainbow Optimum Technologies**. A device identifier may convey information to us about how you browse and use the Service. A device identifier may remain persistently on your device, to help you log in faster and enhance your navigation through the Service. Some features of the Service may not function properly if use or availability of device identifiers is impaired or disabled.

### **Location data:**

When you access the Service by or through a mobile device, we may access, collect, monitor and/or remotely store “location data,” which may include GPS coordinates (e.g. latitude and/or longitude) or similar information regarding the location of your mobile device. Location data may convey to us information about how you browse and use the Service. Some features of the Service, particularly location-based services, may not function properly if use or availability of location data is impaired or disabled.

### **Commercial and marketing communications:**

We use the information we collect or receive, such as your email address, to communicate directly with you. We may send you emails containing newsletters, promotions, and special offers. If you do not want to receive such email messages, you may choose to opt out or change your preferences. We also use your information to send you Service-related emails (e.g., account verification, purchase and billing confirmations and reminders, changes/updates to features of the Service, technical and security notices). You may not opt out of Service-related emails. You may also be able to be “found” on **Rainbow Optimum Technologies** based on information that you provide (see “Find friends on **Rainbow Optimum Technologies** above.

## Use of certain service type information we collect about you:

We use or may use cookies, log file, device identifiers, location data and clear gifs information to: (a) remember information so that you will not have to re-enter it during your visit or the next time you visit the site; (b) provide custom, personalized content and information; (c) to provide and monitor the effectiveness of our Service; (d) monitor aggregate metrics such as total number of visitors, traffic, and demographic patterns; (e) diagnose or fix technology problems; (f) help you efficiently access your information after you sign in; (g) to provide advertising to your browser or device, and (h) automatically update the **Rainbow Optimum Technologies** application on your mobile devices.

## Sharing of Your Information

We will not rent or sell your information into third parties outside **Rainbow Optimum Technologies** and its group companies (including any parent, subsidiaries and affiliates) without your consent, except as noted below:

Who we may share your information with: We may share your information with third-party business partners and Trusted Users for the purpose of providing the Service requested by you. Third party business partners will be given limited access to your information as is reasonably necessary to deliver the Service.

## Who can see User Contents:

Any User Content that you voluntarily disclose for posting to the Service becomes available to the public and might be or may not be removed, except by **Rainbow Optimum Technologies** in its sole discretion? Once posted on **Rainbow Optimum Technologies**, User Content may not be removable from public view, as copies may remain viewable in cached and archived pages of the Service, on other sites that have republished us, or if other Users have copied or saved that information.

If you do not wish your User Content to be available to the public, please don't post it on **Rainbow Optimum Technologies**. Your username and if you choose to disclose it, your real name, will be published publicly. Once published your username and / or real name may not be able to be removed.

Who can see your IP address: If you post User Content on the Service while not logged in, your IP address will be published with your User Content in order to attribute your contribution to the Service. ### **What happens in the event of a change of control:**

Instances where we are required to share your information:

**Rainbow Optimum Technologies** will disclose your information where required to do so by law or subpoena or if we reasonably believe that such action is necessary to (a) comply with the law and the reasonable requests of law enforcement; (b) to enforce our Terms of Use or to protect the security, quality or integrity of our Service; and/or (c) to exercise or protect the rights, property, or personal safety of **Rainbow Optimum Technologies** our Users, or others.

### **Sharing certain service type information we collect about you:**

We may share certain service type information, including information obtained through tools such as cookies, log files, device identifiers, location data and clear gifs (such as anonymous usage data, referring/exit pages and URLs, platform types, number of clicks, etc.): (i) with our third-party business partners for the purposes described in the section above on “How We Collect and Use Information.” We may also aggregate or otherwise strip data of all personally identifying characteristics and may share that aggregated, anonymized data with third parties.

### **Ads on Rainbow Optimum Technologies:**

We may also share certain information such as your location, browser, and cookie data and other data relating to your use of our Service with our business partners to deliver advertisements (“ads”) that may be of interest to you. **Rainbow Optimum Technologies** may allow third-party ad servers or ad networks to serve advertisements on the Service. These third-party ad servers or ad networks use technology to send, directly to your browser or mobile device, the ads and ad links that appear on the Service, and will automatically receive your IP address when they do so. They may also use other technologies (such as cookies, JavaScript, device identifiers, location data, and clear gifs, see above) to compile information about your browser’s or device’s visits and usage patterns on the Service and on other websites, and to measure the effectiveness of their ads and to personalize the advertising content delivered to you.

These third parties may collect information about you including IP address, cookies in ways **Rainbow Optimum Technologies** does not control.

## **How We Store and Protect Your Information**

Storage and Processing:

Your information collected through the Service may be stored and processed in the United States or any other country in which **Rainbow Optimum Technologies** or its subsidiaries, affiliates, or service providers maintain facilities. **Rainbow Optimum Technologies** may transfer information that we collect about you, including personal information, to affiliated entities, or to other third parties across borders and from your country or jurisdiction to other countries or jurisdictions around the world. If you are located in the European Union or other regions with laws governing data collection and use that may differ from U.S. law, please note that we may transfer information, including personal information, to a country and jurisdiction that does not have the same data protection laws as your jurisdiction, and you consent to the transfer of information to the U.S. or any other country in which **Rainbow Optimum Technologies** or its

parent, subsidiaries, affiliates, or service providers maintain facilities and the use and disclosure of information about you as described in this Privacy Policy.

### **Keeping your information safe:**

**Rainbow Optimum Technologies** cares about the security of your information, and uses commercially reasonable safeguards to preserve the integrity and security of all information collected through the Service. However, **Rainbow Optimum Technologies** cannot ensure or warrant the security of any information you transmit to **Rainbow Optimum Technologies** or guarantee that information on the Service may not be accessed, disclosed, altered, or destroyed. Your privacy settings may also be affected by changes to the functionality of third-party sites and services that you add to the **Rainbow Optimum Technologies** Service, such as social networks. **Rainbow Optimum Technologies** is not responsible for the functionality or security measures of any third party.

### **Compromise of information:**
